Oscar has its Headquarters in Torquay, Devon and Offices in Wales, Essex and Northumberland, we are a small flexible organisation, with 90% of our staff being home based.

We continually look for innovative ways of doing business in order to minimise the impact on the environment and local areas and believe in team effort and contribution in order for this to work. When travel is necessary, staff car share, use public transport, or quite simply get walking, thereby helping to keep our carbon footprint low whilst improving physical health.

Senior management have monthly meetings to discuss all aspects of the business, including but not limited to, our impact on the environment, how we can improve on our already low carbon footprint and what we can do to help our local community. We therefore encourage all staff where possible to do all communication via email and telephone, reducing the need for paper, postage and courier services. Staff meetings and monthly PR's are held online to reduce travel around the country. Each region has a single point of contact for all staff thereby reducing the need for paper correspondence and travelling. We use, and have done for many years, a VOIP system for all calls, ensuring our need for onsite telephonic systems/engineer site visits are kept to a minimum, again ensuring our impact on the environment is kept as low as possible.

We are pleased to report that our energy costs for our HO was reduced by 28.02% for the period ending 31 March 2021. Our aim for the next Financial Year is to further reduce this by another 28%. Furthermore, our Energy consultation is primary fulfilled by suppliers using green/renewable sources. Our Stationery and Printer supply costs were reduced by 32.52% for the same period, and we are looking to match this again in the FY ending 2022. We are also aiming to recycle up to 95% of our printer cartridges in the FY ending 2022.

Our CSR Policy is constantly under review to ensure it remains up to date and relevant.
